

# CALGREEN C&D RECYCLING COMPLIANCE INSTRUCTIONS

CALGreen Code requires 65% of Construction & Demolition (C&D) waste to be recycled. For more information on CALGreen Requirements visit:

## STEP - 1

1. Complete C&D Recycling Plan “Before Permit” section. The C&D Recycling Plan “Before Permit” must be completed prior to issuance of your permit. Staff will keep a copy and you will also keep a copy of the Recycling Plan.
  - Review San Benito County’s C&D Recycling Guide and plan for recycling services at your project.

## STEP - 2

1. Contact the C&D recycling services you plan to use for your project.
  - a. See [NEF Approved Haulers List](#). All haulers must have an approved [Non-Exclusive Franchise Permit](#) to do business in San Benito County.
2. Recycle 65% of C&D materials to meet the state requirement.
3. KEEP ALL WEIGHT TAGS for recycling and disposal to document the 65% recycling.

## STEP - 3

1. At conclusion of your project, complete C&D Recycling Plan “Post Construction Report”. See instructions on form and feel free to call IWM for Assistance.
2. Attach all recycling and disposal WEIGHT TAGS to the Recycling Plan.
3. Staff will review and verify your Post Construction Report and WEIGHT TAGS for the 65% verification prior to issuing your final inspection.
