There will also be Eight (8) ex-officio members: One (1) Member from Community-Based Organizations servicing Justice Involved Individuals, One (1) Community Member at Large, One (1) Superior court of San Benito County, Executive Officer, or designee, One (1) San Benito county Behavioral Health Director, or designee, One (1) Sheriff/Jail Commander or designee, One (1) Youth Services Center Program Manager or designee, One (1) City of Hollister Representative, and One (1) Social Services representative or designee
